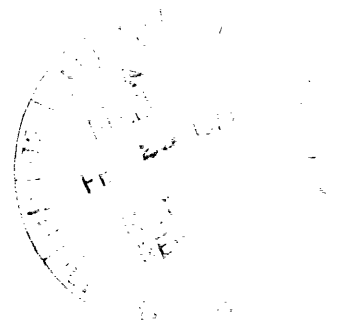

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Built 1820, the Colleton County Court House is a handsomely designed brick building stuccoed to represent stone. Two curving stairways with ironwork railings lead to second floor; extended portico also has ironwork balustrade. Four Tuscan columns and two square, engaged columns support massive, undecorated entablature. Portico shelters double, four-panel doors on either side of portico. Roof-line is formed by parapet extending full width of original center section and surmounted by a shorter, second parapet. Raised, arcaded basement below portico. Two large wings were added to original structure in 1939.

STATEMENT OF SIGNIFICANCE

The Colleton County Court House has significance architecturally as a fine example of Greek Revival architecture probably designed by Robert Mills and built by J. & B. Lucas, noted Charleston contractors. Historically, its significance is derived from the fact that the first public meeting on nullification was held here in June, 1828.

It was at this meeting that Robert Barnwell Rhett delivered his militant Walterboro address urging Governor John Taylor to call an immediate session of the state legislature for the purpose of openly resisting tariff laws. In late October, 1828, James Hamilton, Jr. organized a second meeting of the Court House and proclaimed the necessity of "nullification by the state...of the unauthorized act."

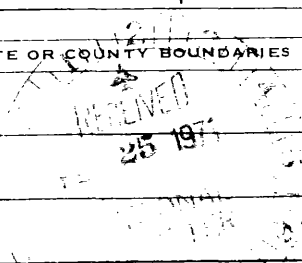
