





DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Federal style three story brick building five bays wide exhibiting hipped roof, double front door crowned by a transome, string courses, sash windows and hand-hammered hardware. Front foundation wall is cut granite, others are rubbal granite, veneered with brick. Walls are eighteen inches thick to the third floor and fourteen inches from that point to the roof. Brick on front wall is Flemish bond, the side and rear walls are of common bond. The flat arches over front openings are made of wedge shaped bricks with rubbed surfaces. Side and rear arches are of similar design. A fireplace for each room is provided through one of the four chimneys.

All floors have central halls that extend through the house from front to rear with two rooms on either side. The staircase is in the rear portion of the hall and floors are of heart pine. Plastered hallways and high-ceilinged rooms are decorated with wainscotting, mantels with elliptical designs, and cornices, all in keeping with building's dignity.


STATEMENT OF SIGNIFICANCE

Built about 1830 by Richard Cathcart and is a highly unusual example of Federal architecture in central South Carolina. House was sold to George Washington Ladd in 1852 and was used as a school for girls until closed by the Civil War. In 1862, property was sold to Phillip E. Porcher, and was again sold in 1874 to Priscilla Ketchin. About thirty-five years ago the roof and cornice burned, but was replaced in 1970 resembling original. John W. Cathcart acquired the property in 1938. Last year it was deeded by his daughters to Fairfield County.

The building is remarkably unchanged and is presently being restored to house the Fairfield County Historical Museum.

House is almost an exact replica of Heyward-Washington House, Charleston, which has been designated as a National Historic Landmark.


