The Burdette Building, at 104 East Curtis Street (at the corner of East Curtis and South East Main Streets) in Simpsonville, Greenville County, South Carolina, was listed in the National Register of Historic Places on July 17, 2003. As a result of professional error in the original nomination document, the original boundary marked on the Greenville County tax map included two adjacent parcels under the same ownership and included buildings and structures that were not listed (and not intended for nomination) in the Narrative Description of the original nomination. The boundary is being decreased to clarify the nominated area and to exclude several altered and/or non-historic buildings and structures.

The buildings and structures to be excluded as a result of the boundary decrease have substantial alterations and additions completed after the period of significance for the Burdette Building. These buildings do not contribute to the significance of the Burdette Building.

The following buildings and structures are located within the area of the boundary decrease:

- 1) **Barefoot Annie's Coffee Shop**. A one-story early twentieth-century brick commercial building not related to the history of the Burdette Building during its period of significance. This building is located on a separate but adjacent parcel under the same ownership. Parcel boundaries were unclear on the Greenville County tax map that was available at the time of the original nomination and this contributed to the error made in marking the National Register boundaries on the map.
- 2) Warehouse I. A concrete block warehouse with shed additions.
- 3) **Warehouse II**. A warehouse with metal siding on the south end and vinyl siding on the north end (the end most visible from East Curtis Street, the public right-of-way).
- 4) **House**. A late nineteenth-century frame house with late twentieth-century alterations and additions, including vinyl siding and a two-story rear wing that is more industrial in character than typical wing additions on residential buildings of its period.
- 5) **Silo/Grain Bin**. A mid-twentieth century cylindrical, corrugated metal storage container with a shallow, conical roof.
- 6) **Shed**. An early to mid-twentieth century small frame shed with corrugated metal siding.
- 7) **Cottage**. An early twentieth century small frame cottage with synthetic siding applied and an enclosed porch.

Verbal Boundary Description

The revised boundary of the nominated property is defined as the heavy black line indicating the footprint of the Burdette Building on the accompanying copy of a plat titled "Boundary Survey for Burdette 100, LLC", scale 1:30, dated August 28, 2006, created by MSP & Associates Land Surveys, Inc., Greenville, S.C.

Boundary Justification

The nominated property is restricted to the footprint of the historic building, consisting of the two-story Burdette Building (built 1921), a one-story addition on South East Main Street (built ca. 1945), and a one-story section on East Curtis Street that includes the surviving portions of a two-story 1913 building historically associated with the Burdette Building, but which was damaged by fire in 1969 and subsequently given a new brick façade.








