

## Describe the present and original (if known) physical appearance

The Kendall Mill Historic District, located on the east side of the city of Camden, South Carolina, contains eight properties of key historic or architectural significance and 113 supporting properties. The district has as its central focus the Wateree Plant of Kendall Mills, built in 1899 in the Romanesque Revival style. The mill faces Kendall Park, a ten-acre landscaped park. On the eastern border of the park are the mill supervisors' houses, built between 1900 and ca. 1925. The operatives' housing, which lies in the southeast corner of the district, consists of one-story, one-and-one-half-story, and a few two-story frame houses which date from 1900 to 1923. North of the mill the district includes Kendall Lake. Most of the buildings in the district retain their original architectural features and are in good repair.

## Key properties contributing to the character of the historic district:

- 1a. Wateree Plant of Kendall Mills, 90 East Hampton Street: Built in 1899 according to a design by W. B. Smith Whaley, the designer of Olympia Mills in Columbia, S. C. The original portion of the building consists of the central plant block and boiler room. This original plant building is a four-story rectangular brick building with a back stair tower and an imposing six-story front stair tower. The front tower has a Romanesque arched entrance, front and side recessed panels in which windows are set, arched windows on the sixth floor, and a pyramidal roof. The boiler is a three-story, rectangular, brick building with a series of recessed three-story arches into which the windows are set. On the south wall the second floor windows are double with a transom, and on the third floor the double windows have lunettes. The east side of the boiler room has only third story lunette windows. The windows of the main plant building, which feature segmental brick arches, were bricked up in 1961. The west addition to the plant, which is in keeping, architecturally, with the older buildings, was constructed in 1964. On the southwest corner of the front stair tower is the canteen, which was built in 1969. (See photos 4, 4a)
- 1b. Office of the Wateree Plant of Kendall Mills, 90 East Hampton Street: Built in 1899, a one-story, rectangular, brick building with a full basement and a rear ell. Running along the northeast, northwest, and southeast walls are arcades, in which are set double windows topped with fanlights. A decorative brick cornice encircles the top of the building. (See photo 5)
2. Kendall Lake, borders the northeast corner of Camden: a fifty-acre lake fed by Pine Tree Creek. The lake, which appears on a 1762 plate, has powered grist mills, saw mills, tanneries, and cotton mills throughout the eighteenth, nineteenth, and early twentieth centuries. The present mill, although not powered by the lake water, uses the lake for general water purposes. The lake was given to the city of Camden by Kendall Mill. (See photo 11)
3. Kendall Park, bordered by Haile Street, East Hampton Street, Park Circle, and Lakeshore Drive: gently rolling ten-acre site through which Pine Tree Creek runs. Kendall Mill gave the park to the city in 1964. (See photo 10)

**Statement of Significance (in one paragraph)**

The Kendall Mill Historic District, located in the eastern section of the city of Camden in Kershaw County, South Carolina, is centered around the Wateree Plant and associated structures, which date from 1899 to 1923. The district contains 121 properties which illustrate the growth of the companies which utilized the plant through the years. The mill village to the south and southeast of the plant was built between 1900 and ca. 1925 and is a virtually intact reminder of the importance of the textile industry to South Carolina.

The Dekalb Cotton Mill was organized in 1899 and capitalized at a cost of \$144, 000.<sup>1</sup> The Dekalb Mill building, designed by W. B. Smith Whaley, architect of the Olympia Mills in Columbia and numerous other mills throughout the South, was considered a model of textile architecture.<sup>2</sup> Operations began in 1901 with 12, 500 spindles and 300 looms which produced high quality print fabric.<sup>3</sup> A mill village of seventy homes was also constructed at this time.<sup>4</sup>

In 1902 the mill ceased operations and remained closed for over a year.<sup>5</sup> The mill was reorganized as Pine Creek Manufacturing Company and had 250 employees and a mill village population of 700 persons.<sup>6</sup> The mill village had a church for which the company contributed \$200.00 and the land on which the building was constructed.<sup>7</sup> In 1910 the mill increased its production with the addition of 8,816 spindles and 182 looms.<sup>8</sup> Also at this time new houses were built in the mill village. Around 1908 the mill was bought by Thomas Parker Corporation of Greenville, South Carolina, and remained under Parker interests until 1916 when Lockwood, Greene, and Company of Boston purchased it for H. P. Kendall.<sup>9</sup> In 1921 the plant was modernized with new looms, and additional card room machinery. Twelve new homes were added to the mill village at this time.<sup>10</sup> The mill village also had a store, baseball team, and band.<sup>11</sup> In 1948 the ninety-nine homes which comprised the mill village were sold to the employees. Today the Kendall Wateree Plant is a subsidiary of Colgate-Palmolive Company.

4. Superintendent's House, 1519 Park Circle: ca. 1905, an asymmetrical, two-story, weatherboard, gable ended house. On the front is a one-story porch with chamfered posts and a plain wooden balustrade. The corner has a one-story, projecting, three-sided bay with a pedimented front gable with overhanging eaves. The bay arrangement is B/A/BBB\* with two-over-two sash windows. Front door has side-lights. (See photo 6)
5. Office Manager's House, 1515 Park Circle: ca. 1925, an asymmetrical, one-story, weatherboard house with a hipped front dormer. The front porch has wooden posts for support and a plain wooden balustrade. Bay arrangement is B/A/BB.\* (See photo 7)
6. Plant Manager's House, 1507 Park Circle; ca. 1925, an asymmetrical one-story, weatherboard house with hipped front dormer. The wraparound front porch is supported by Tuscan columns. The southern portion of the porch has been enclosed, and there is a ca. 1965 addition on the back of the house. (See photo 8)
7. 1505 Park Circle: ca. 1925, an asymmetrical, one-story, weatherboard house with exposed rafters. The bay arrangement is B/B/B\* with the entrance on the north screened in porch. (See photo 9)

Other properties contributing to the character of the district:

The contributing mill housing consists of seven house types, A-G. After the original descriptions, properties will be designated by their type.\*\*

61. Type A, 2135 Wateree Street: ca. 1900-1923, a one-story, rectangular, weatherboard gable ended cottage with central chimney and rear back ell. Front shed porch is supported by square posts. Bay arrangement is B/A/A/B with six-over-six windows. (See photo 12)
72. Type B, 2000 Lakeshore Drive: ca. 1900-1923, a one-story rectangular, weatherboard cottage with low pitched gable roof and inside chimney. Roof extends to cover porch on facade. Bay arrangement is B/A/B/B with sash windows. (See photo 13)
107. Type C, 1810 Pine Creek Avenue: ca. 1910-1923, a one-story, frame, gable ended cottage with a catslide roof. Front shed porch is supported by square posts. (See photo 14)
112. Type D, 1760 East Haile Street: ca. 1910-1923, one-story, frame, L-shaped house. Front porch is supported by square posts. Bay arrangement is A/B/A/A with six-over-six windows. (See photo 15)

- 1f. Air House, 90 East Hampton Street: ca. 1912-1923, a half-story, square, wood building with pyramidal roof with finial.
- 1g. Warehouse-Opening Room, 90 East Hampton Street: ca. 1899-1923, a large, rectangular, brick building with a low pitched gable roof and party walls. Fanlight windows are on the east.
- 1h. Hose House, 90 East Hampton Street: ca. 1912-1923, a half-story, square wood building with pyramidal roof and wooden finial. Lattice work under the eaves.

- 1i. 90 East Hampton Street: a large, rectangular, brick cardingroom. Southern part built ca. 1970, and the northern portion built in 1980. (See photo 18)
- 1j. 90 East Hampton Street: a large metal water tower. (See photo 19)


