Describe present and historic physical appearance.

The Civilian Conservation Corps (CCC) Quarry (#1) and Truck Trail are located approximately one mile south of Table Rock State Park and are situated in a wooded area. This quarry consists of a granite outcropping mined by the CCC during the construction of Table Rock State Park. It was mined from a creek bed which is now approximately twenty yards distant from the quarried ledge. The ledge is sheer and approximately twelve feet in height. Dynamite holes from the last mining activity remain intact near the ledge. These round holes are spaced at approximately two foot intervals and were designed to hold dynamite during the blasting process.

The Truck Trail or quarry road begins at South Carolina Primary Road 11 near the intersection of Secondary Road 25 and proceeds three-quarters of a mile to the quarry. The roadbed and crushed gravel surface remain intact, as do turnouts or wide areas along the shoulders of the road.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Civilian Conservation Corps (CCC) Quarry (#1) is significant as one of four quarry sites used for materials in the construction of park structures and facilities at Table Rock State Park. This was the final quarry site used by the CCC for park construction and the second located off park property. There had been other sites where rock was obtained and quarried, two of which were located within the park boundaries, but these had already been exhausted. The South Carolina State Commission of Forestry obtained the rights to quarry on land owned by Edward and Anna Chastain in July 1939 for fifty dollars. The site was chosen because of its location and the "ample quantity" of stone available to complete structures in progress and "for all future park construction." Rock was obtained by drilling holes into the granite outcrop and placing sticks of dynamite into them. Blasting is to have been done with such precision that the pieces of granite were ready for use as they were. Rock was also obtained by drilling holes into the rock and placing wedges in the holes. These were hammered into the rock until it split.(1)

The truck trail or quarry road is significant for its construction by CCC workers to gain access to the quarry. The road was constructed to endure everyday use by trucks that would be loaded with men and materials until the park was completed. For a distance it followed along an old farm and logging road that was no longer passable. The road was made wide enough and with frequent turnouts to make hauling safe. The truck trail was covered with crushed rock to make it serviceable at all times of the year. It was also barricaded at the entrance when not in use for the protection of the property owners.(2)
