



**NARRATIVE DESCRIPTION OF RESOURCE**

*Cook's Lake Cattle Mound, HS-02*

An approximately 3-foot-high-by-165-foot-circumference, oval-shaped earthen mound located [REDACTED]

The mound is covered with vegetation including mature, old-growth bottomland hardwood trees that range widely in species variety and age. Inundation and erosion caused by seasonal flooding impact the structure, but the mound retains a high degree of location, design, setting, materials, workmanship, feeling, and association integrity.

**NARRATIVE STATEMENT OF SIGNIFICANCE**

Cook's Lake Cattle Mound is significant under the context "Agricultural Settlement in the Congaree Swamp: 1740-1900" established in the National Register of Historic Places Multiple Property Documentation Form for the *Historic Resources of Congaree Swamp National Monument*. Free-ranging livestock provided a significant source of food and income prior to the Civil War in the South Carolina back country. Settlers in the Congaree Swamp constructed cattle mounds to provide a place of refuge for hogs, cattle, and other grazing animals during the flood season. Farmers constructed many of the earthen structures in the swamp using slave labor. The original owner of Cook's Lake cattle mound is unknown.

The cattle mound is significant at the state level under National Register criteria A and D for its association with the agricultural settlement of the Congaree Swamp and for its ability to yield information about settlement patterns in the region.
