



Originally was simple rectangular one-story house with loft; constructed on field stone foundation piers; gabled roof and end field stone chimney.

"L" addition of same height with clapboard siding at rear; possesses a one-story lean-to front porch supported by square columns.

Addition is two bays wide (one window and one door); open riser steps lead to door; small inside brick chimney slightly below ridgepole.

Interior has field stone fireplace with large field stone lintel.

This house stands alone on one acre of surrounding land, and at the crest of a knoll overlooking the city. It is located within the city limits of Spartanburg, one of the state's most thriving and most densely populated textile areas. The property is just across the street from a low-rent housing project. The Spartanburg County Historic Preservation Commission is interested in restoration of the house and grounds as a community center with park and is applying for a HUD grant to accomplish this. (The house has been inspected by William Clarke of the HUD regional office in Atlanta).

STATEMENT OF SIGNIFICANCE

The Jammie Seay House, believed to be the oldest house within the present limits of Spartanburg, is a good example of log cabin construction.

Built between 1770-1800, the house belonged to Jammie Seay, a Revolutionary War soldier of the Second Virginia Infantry who was born in Virginia in 1752 and died in Spartanburg County in 1850.

Columbia architect, Walter Petty, FAIA, made the following statement concerning the architectural significance of this house: "Despite its terrible physical condition, this is an unusual example of the early log house with the log structure protected from the weather by wood sheeting. The interior showing the log construction work exhibits a degree of craftsmanship not usually found in cabins of this period. The fieldstone chimney, of the 'pipestem' form, is not typical of South Carolina and probably evidences the fact that Jammie Seay was a native of Virginia, where this type chimney (laid in brick) was very typical. I think this should be restored as a fine example of a pioneer residence."
