The Pacolet Mills Historic District is an early twentieth century South Carolina textile mill village. It is located in the town of Pacolet, approximately 15 miles southeast of the city of Spartanburg. The district is bounded on the north by the Spartanburg County/Cherokee County line, on the south by the community of Central Pacolet, on the west by the White Rose Cemetery and Section Four (the historically African American section of Pacolet Mills, also known as Marysville), and on the east boundary by hilly countryside. The mill village is bisected by the Pacolet River.

The Pacolet Mills village was historically divided into four sections. The boundaries of the Pacolet Mills Historic District includes three of these sections. Milliken Avenue is the central boulevard in Section One and Montgomery Avenue is the central boulevard in Section Two. Section Three sits across the Pacolet River from Sections One and Two and is connected to the other sections via a bridge built in 1953. All of the side streets in the entire village are lined with neat rows of mill houses. Tree plantings are along the main boulevards in each section. Section Four of the village was historically the African American section of the village, known as Marysville; its relative geographic isolation from Sections One, Two and Three and its relative lack of architectural integrity have made it advisable to exclude Section Four from this district. The nearby Marysville School on Sunny Acres Road, built by the Pacolet Manufacturing Company for African American children in 1915, was individually listed in the National Register on January 9, 2007.

There are 243 properties in the Pacolet Mills Historic District: 129 properties contributing to the character of the district and 114 properties that do not contribute to the district. The majority of the houses have undergone alterations since their initial construction. The most common of these alterations are asbestos siding (added after the homes were sold in 1955), new porch railings not matching the original, infill of porches, aluminum or vinyl siding, and replacement of windows. In spite of these types of alterations, approximately 50% of the houses retain their basic form and characteristics and contribute to the historic character of the district. These houses illustrate the characteristics of housing in the village in the early twentieth century.

Approximately 50% of the older houses have been significantly altered and no longer contribute to the historic character of the district. Changes to these homes include modern large scale additions.

The Pacolet Mills Historic District features a variety of mill village house types. Most were built between 1915 and 1920, with a few built ca. 1950. There are five main house types, with subtypes identified by letters:

There are 28 Type 1A houses. The Type 1A house is a one-story simple duplex with a rectangular floor plan and a gable end roof. The façade has a center gable with a porch on either end. Four windows are centered between these porches. A door is located on the side of each porch. There is a central chimney and the siding is a mixture narrow width weatherboard siding and shingles.

There are 15 Type 1B houses. The Type 1B house is a one-story simple duplex with a rectangular floor plan and gable end roof. The façade has a center shed and a porch on either end. Four windows are centrally located between the two porches. A door is located on the side of each porch. There is a central chimney and the siding is a mixture narrow width weatherboard siding and shingles.

There are four Type 1C houses. The Type 1C house is a one-story simple duplex with a rectangular floor plan and gable end roof. The façade has a center shed that is flanked on each side with a smaller gable. There is a porch on either end with four windows centrally located between the two porches. A door is located on the side of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are two Type 1D houses. The Type 1D house is a one-story simple duplex with a rectangular floor plan and gable end roof. The façade has a large center gable and is flanked on either side with two small sheds. There is a porch on either end with four windows centrally located between the two porches. A door is located on the side of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There is one Type 1E house. The Type 1E house is a one-story simple duplex with a rectangular floor plan and gable end roof. The façade has a large center gable and is flanked on either side with two smaller gables. There is a porch on either end with four windows centrally located between the two porches. A door is located on the side of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are 20 Type 1F houses. The Type 1F house is a one-story simple duplex with a rectangular floor plan and gable end roof. The façade has a porch on either end with four windows centrally located between the two porches. A door is located on the side of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are 117 Type 2 houses. The Type 2 house is a one-story single family residence with a rectangular floor plan and front gable roof and a hipped porch. This home has an extension to the back façade that extends the area of the home. The façade has a central door with a window on either side of it. There is a chimney on the right side of the house and the siding is narrow width weatherboard or shingle siding. Some type 2 houses have a basement with windows, depending on the land they were built on.

There are nine Type 2A houses. The Type 2A house is a one-story single family residence with a rectangular floor plan and front gable roof and a hipped porch. The façade has a central door with a window on either side of it. There is a chimney on the right side of the house and the siding is narrow width weatherboard or shingle siding.

There are five Type 2B houses. The Type 2B house is a one-story single family residence with a rectangular floor plan and front gable roof and a gable porch to the right. Some of these type homes were mirrored throughout the community. The façade, from the left, has a double window and a single door centered on the porch. There are two chimneys centrally located in either side of the house and the siding is narrow width weatherboard or shingle siding.

There is one Type 2C house. The Type 2C house is a one-story single family residence with a rectangular floor plan and front shed porch. The façade has a door to the left with a window on on the right. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are five Type 3A houses. The Type 3A house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center gable and is flanked on the left with a shed porch and a gable porch on the right. Four large windows are centrally located between the porches. A door is located on the side of each porch and a small window is on the façade of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are two Type 3B houses. The Type 3B house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center gable and is flanked on each side with a gable porch. Four large windows are centrally located between the porches. A door is located on the side of each porch and two small windows is on the façade of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are two Type 3C houses. The Type 3C house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center shed and is flanked on each side with a gable porch. Four large windows are centrally located between the porches. A door is located on the side of each porch and two small windows is on the façade of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are two Type 3D houses. The Type 3D house is a one-story complex duplex with a rectangular floor plan hipped end roof. The façade has a front center hip gable and is flanked on each side with hipped porches. Four large windows are centrally located between the porches. A door is located on the side of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are two Type 3E houses. The Type 3E house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center hip shed and is flanked on each side with hipped sheds. Four large windows are centrally located between the porches. A door is located on the side of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are two Type 3F houses. The Type 3F house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center gable hip and is flanked on each side with gable hipped porches. Four large windows are centrally located between the porches. A door is located on the side of each porch and two small windows is on the façade of each porch. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There is one Type 3G house. The Type 3G house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center shed hip and is flanked on each side with a gable hips. Four large windows are centrally located between the porches. A door is located on the side of each. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There is one Type 3H house. The Type 3H house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center shed and is flanked on each side with hipped gable porches. Four large windows are centrally located between the porches. A door is located on the side of each. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There is one Type 3I house. The Type 3I house is a one-story complex duplex with a rectangular floor plan gable end roof. The façade has a front center hip gable and is flanked on the left with a hipped shed porch and a hip gable porch on the right. Four large windows are centrally located between the porches. A door is located on the side of each. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There are six Type 4 houses. The Type 4 house is a two-story single family home with a rectangular floor plan and a front gable roof. The façade has a recessed front gable porch. The façade of the first story has a central door with a window on either side. The upper story had one window in the gable porch and one on the façade. A side shed roof is present in this type house with a central chimney and the siding is narrow width weatherboard or shingle siding. Some Type 4 houses are mirrored throughout the village.

There are six Type 5A houses. The Type 5 house is a one-story single family home with a rectangular plan with a back extension and a side gable roof. The façade has a front shed porch with a central door. One window is located to the right of the door. There are two central chimneys and the siding is narrow width weatherboard or shingle siding.

There are five Type 5B houses. The Type 5B house is a one-story single family home rectangular floor plan with a back extension and a side gable roof. The façade has a front gable porch with a central door. One window is located to the left of the door. There is a central chimney and the siding is narrow width weatherboard or shingle siding.

There is one Type 6 house. The Type 6 house is a story and a half single family home with a rectangular plan with front gable. The façade has a full front gable porch with a central door. There is a window on either side of the door. There are two tall chimneys on the right roof and a shed dormer on the left room. The siding is narrow width weatherboard siding.

There is one Type 7 house. The Type 7 house is a story and a half single family home with a rectangular plan with end gables. The façade has a full front gable porch with a central door, flanked by paired window each side. There are two central chimneys at the roof ridge and a shed dormer on the front. The siding is wide replaced siding.

There is one Type 8 house. The Type 8 house is a two-story single family home with a rectangular plan and hipped roof. The façade has a full front porch with a door on the right and a tripartite window to the left. There are decorative chimneys at the roof edge. There is a dwelling extension to the left. The siding is narrow width weatherboard siding.

Earle S. Draper's 1919 landscape plan for the Pacolet Mills village featured paved streets and sidewalks—unusual in most textile mill villages of the period—as well stone or concrete terraces, walls, and steps, and parks and other green spaces. Such landscape features all contribute to the historic, architectural, and landscape character of this historic district.

Properties Contributing to the Character of the Pacolet Mills Historic District:

- 1. **Montgomery Memorial Methodist Church (ca. 1910, extensively renovated ca. 1927), 161 Limestone Street**: This building, originally built ca. 1910 as a Neoclassical design, was renovated by Casey and Fant Architects of Anderson ca. 1927 and is a red brick building of Gothic Revival design. The roof of the educational building is of the cross gable type. The stained glass windows are 6 over 6 in the educational building and the sanctuary has a 3 part arch top window flanked by smaller windows on each side.
- 2. **Pacolet Mills Baptist Church, 150 Stone Street (ca. 1920)**: This building, designed by Luther D. Proffitt, is Shingle-style design. The sanctuary section of the building has a gable roof with a large arch in its front façade. There are 5 stained glass windows in this arch. The tower has a stone base with a large overhang and arched tops over the double doors on 2 facades. Centered over these doors is a pair of arch top louvers. The interior of the sanctuary is well developed architecturally. The original plaster infill between exposed trusses has been replaced with light colored wood finish.
- 3. Pacolet Mill Office (1908), 180 Montgomery Avenue: In the center of the village, this building (in 2007 the Pacolet Town Hall) was individually listed in the National Register July 28, 2004. The building is constructed of brick laid in a seven-to-one American bond, but with the variation that the bonding course consists of alternating stretchers and headers. A stone watertable surrounds the building and acts as a beltcourse separating the floors visually on the two-story section of the building. The roof, clad with clay Spanish tile, is a low-pitched hip roof with flared eaves and decorative exposed rafter tails. Two flared and hip roofed dormer vents pierce and punctuate the building's roofline on both the east and west elevations. One of the more interesting architectural elements on the building's site is a curving cast stone or concrete pergola that stretches from the main level entrance on the left (west) elevation along a walkway. It is believed the pergola was added some time between 1920 and 1927.
- 4. Pacolet Mills Cloth Room and Warehouse (1906-1907), 1560 Sunny Acres Road: Located next to the Pacolet Mill Office, the Pacolet Cloth Room and Warehouse was individually listed in the National Register February 1, 2006. The cloth room portion of the one-and-one-half-story building is constructed of brick laid in common bond, with the warehouse portion covered with weatherboard and metal. The building features a low-profiled roof and symmetrical design, as well as large rounded arch windows. The building served two functions: the front portion was used for inspecting cloth produced by the mills prior to shipping, and the rear portion was used as a warehouse.

The Pacolet Mills Historic District, in the Piedmont section of Spartanburg County, South Carolina, is eligible for listing in the National Register of Historic Places under Criterion A for its significance in Industry and Community Planning and Development, and under Criterion C for its Architecture and Landscape Architecture. This district is an excellent example of an early to mid-twentieth century South Carolina textile mill village, one centered around a mill that opened in 1883 and closed in 1983, including significant designs by architects J. Frank Collins and Luther D. Proffitt and landscape architect and planner Earle S. Draper.

The Pacolet Mills Historic District includes the mill office (in 2007 the Pacolet Town Hall), a cloth room and warehouse, two churches and 237 supervisor and operative houses. Although the three main Pacolet Mills—built in 1883, 1888, and 1891, respectively—and a fourth mill built in 1894 were demolished in the late 1980s, the Pacolet Mills village was laid out and built in 1919 and is largely intact. The road system in the four major sections of the Pacolet Mills village is also intact.

Though this area was settled before the American Revolution, and a post office was established nearby in 1831, the town—first known as Buzzard's Roost—did not prosper until the Spartanburg and Union Railroad laid tracks through it in 1855. When Pacolet Station was built four years later, and the town changed its name to Pacolet; it was finally incorporated in 1896, in the midst of the textile boom and just after the construction of the last mill here.

According to a short online history of Pacolet prepared by Susan Thoms of the Kennedy Room of Local and South Carolina History at the Spartanburg County Public Library,

The origin of the name Pacolet has two camps of thought. Both, however, agree that the river was named first. One camp says the name is of Cherokee Indian origin and means "fast running horse." The other camp says the river was named after a French settler named Packolette. The name can be traced to "Valentine and Orson." A 15th century French prose romance set in the 8th century rule of King Pepin. In it, a dwarf in the service of Lady Clerimond rides a swift, winged horse named Pacolet.

Whatever the origin, the theory of the fleet horse was so widely held that a running horse was the logo at Pacolet Manufacturing. Elderly Pacolet residents of the 1980's recalled a shipment being returned from China in the early 1900's because it did not bear the stamp of the running horse. Chinese authorities did not consider the textiles authentic without that horse.

The first Pacolet Manufacturing Company was founded in 1848 by Gabriel Cannon, Joseph Finger, and Henry Kestler; they built small textile mills at what was later named Fingerville, on the Pacolet River about twenty miles northwest of Pacolet. The first Pacolet Manufacturing Company mill on this site (known as Pacolet Mill No. 1 or Pacolet No. 1) was built in 1883 by John H. Montgomery, John B. Cleveland, Joseph Walker, and Dr. Charles Edwards Fleming, with the financial aid of Seth M. Milliken of New York.

By 1884, the village of Pacolet Mills contained 62 cottages and several boarding houses for Pacolet's 500 operatives. Pacolet No. 2, a four-story mill adjoining the first mill, was built in 1888; Pacolet No. 3 was built in 1891; and a fourth mill was built in 1894.

The textile mill village that grew up here was first called Trough Shoals, or simply Trough; it was renamed Pacolet Mills in 1930. The Pacolet area was historically divided into four distinct mill communities: Pacolet, Central Pacolet, Pacolet Mills, and an unincorporated area known as Pacolet Park.

When the Pacolet River flooded on June 6, 1903, it destroyed Clifton Mill No. 1 and half of Clifton No. 2—about ten miles upstream from Pacolet—and killed at least 64 people there, then destroyed Pacolet Nos. 1, 2, and 3, and a significant portion of the mill village along with it, killing one person there. An extra evening edition of the *Spartanburg Journal* announced: "By Raging Waters. Cotton Mills, Warehouses, Cotton and Goods Washed Away. Appalling Calamity of Rainfall. Deluge Fell in Spartanburg Last Night. Bridges Swept Away. Most Appalling Loss of Property in the History of the County. Over a Million Dollars Total Loss." A headline for an article about the destruction at Pacolet reported, "3 Pacolets Gone. The Entire Manufacturing Plant Swept Away by the Waters. Dead Bodies Floated By In Stream; Presbyterian Church Among the Destroyed. Thousands Idle There. Magnificent Industry Which Ha[s] Been a Most Successful One Washed Down Torrent of Pacolet River."

The calamity was later estimated to have killed nearly 70 people, left 600 homeless and 4,000 jobless, and caused more than \$670 million worth of damage in today's value.

Pacolet Nos. 1, 2, and 3 were rebuilt in 1905, and by 1907 Pacolet was the largest manufacturing complex in Spartanburg County and one of the largest in the South. That year a poster was circulated in the mountains of North Carolina and Tennessee advertising the need for "500 Operatives to Work in a Cotton Mill. The advertisement promised

steady employment for over 300 days in the year for boys and girls over age 12 years old, [and] men and women at average wages [per day] as follows:

Experienced 12 to 16-year old boys and girls from 50 cents to \$1.25. Experienced boys and girls over 16, and men and women, 75 cents to \$1.50. Old men, 60 to 70 years old, 75 cents to \$1.

The advertisement continued,

We furnish you good, comfortable houses at 50 cents a room per month. . . . Pacolet Mills houses are located on a hill and the place is noted for its health and is free from all malarial diseases. Only a short distance from the North Carolina mountains. We have good water, a splendid system of free schools, churches of different denominations; in fact everything that appeals to one who wishes to improve the condition of his family. Our mill is heated with steam and is warm and comfortable in the winter. We make coarse cloth and can have our windows open in the summer to give nice cool air through the mills. If you are a poor man there is no better location for you to select than Pacolet. . . . We want families with at least three workers for the mill in each family. ³

The mill village as it appears today dates predominantly from the period 1915-1920, during the second great boom period of the several Pacolet Mills. Several community buildings were built soon afterwards, among them the Montgomery Memorial Methodist Church, (ca. 1910, with renovations and enlargements in 1927); the Pacolet Mills Baptist Church (ca. 1920); the Pacolet Graded School (1921); an amphitheater (1924); and a company store with a post office, men's club, girls' club, and an ice cream parlor. An addition to the company nurse's house was built as a day care center for children whose mothers worked in the mill. In 1927 Dr. R.G. Beachley, Deputy State Health Officer of Maryland, published an article in *Nation's Health* extolling the virtues of Pacolet Mills, describing the village plan and housing as

not the ordinary form of shack or small frame house so often seen in the mill villages of the South, but each family occupies a detached bungalow built along most modern lines, with attractive architectural designs. In passing through the village one might believe he was in a suburb of a modern American city to judge from the appearance of the streets, homes, and surrounding yards.⁴

In 1955 the mill sold the village housing at auction. In 1981 weaving was shut down; in 1983 spinning was shut down and the Pacolet Mills closed. The mills were demolished in the late 1980s.

The district is also significant for its examples of the work of architects J. Frank Collins and Luther D. Proffitt and landscape architect and city planner Earle S. Draper, all of them prominent not only in early- to mid-twentieth century South Carolina but in the Southeast as well. Collins designed the supervisors' and workers' houses (1915-1920), Proffit designed the Pacolet Mills Baptist Church (ca. 1920), and Draper designed the plan and landscape features of the village (1919).

J. Frank Collins (1883-1969), a native of North Carolina, attended Davidson College before moving to Spartanburg in 1910. Collins was active in the Spartanburg area 1911-1936, and was associated with Joseph B. Simpson as Collins and Simpson 1923-26. He designed not only "all of the principal homes and other buildings at Pacolet," as a biographical sketch noted in 1935, but other mill village projects in Spartanburg and Spartanburg County as well, including the Drayton Mills Community Building (1919) and the Clifton Graded School (1921) and Clifton Methodist Church (1927) at Clifton Mills; remodeling and additions to the Spartan Mills Community Building (1922); and the Spartan Mills Community House (1924). Collins was also the architect for several other significant projects in Spartanburg during the 1910s and 1920s, including the Spartanburg Y.M.C.A. (1913-14); Spartanburg General Hospital (1919); Cummings Street School (1926); Masonic Temple (1927); First Baptist Church; the Sunday School Building for First Baptist Church (1927); the Office and Shop Building, Spartanburg Water Works (1927); the James F. Byrnes House (1927); the Spartanburg County Tuberculosis Sanitarium (1929), the Andrews Field House at Wofford College (1929); and significant remodeling and additions to Esther Andrews Hall at Converse College (1929).

Luther D. Proffitt (active 1899-1936), who began his career as a carpenter, was practicing as an architect by 1904, practicing in Spartanburg in association with a man named McNeal (or McNeil). Proffitt was associated with Thomas Keating as Keating and Proffitt in 1905-06; with S.P. Tinsley as Proffitt and Tinsley in 1908; and with Martin Luther Hampton as Proffitt and Hampton in 1910-11. He was on his own in 1909 and again from 1911 to 1936. Proffitt's other textile mill village design was a church for Whitney Mills (1907). He was also the architect for several significant projects in the upcountry from1907 to 1929, including the Spartanburg City Hall (1907); Second Presbyterian Church (1907); Spartanburg Land and Improvement Company Building (1908); Steedly Hospital (1916); B'nai Israel Congregation Synagogue (1917); and Prospect Baptist Church (1922) in Spartanburg, as well as the Gaffney Presbyterian Church (1907); Union Firehouse (1909); remodeling and additions to the Laurens County Courthouse (1911); Woodruff Presbyterian Church (1911); First Baptist Church, Simpsonville (1913); and Pacolet High School (1929).

Earle Sumner Draper (1893-1994), a native of Massachusetts, received a degree in landscape architecture from Massachusetts State College (now the University of Massachusetts) in 1915. John Nolen, city planner of Cambridge, Massachusetts, hired Draper to run a Southern office for him in Charlotte, North Carolina, and after two years Draper opened a practice of his own, becoming the first city planner working in the South to actually live there. Specializing in designing—or redesigning—textile mill villages, Draper's location in Charlotte put him in

the heart of the Piedmont cotton mill region. As the economy of the New South boomed, the expanding textile industry provided Draper with commissions for mill villages in every southern state. As the only local expert in mill village design, Draper had to confront an already wellestablished settlement type. . . . The southern textile industry depended on a physical setting—the mill village—for its economic survival. . . . In more than a hundred plans, Draper completely redesigned the textile town, drawing inspiration from the Piedmont landscape and his knowledge of the lives of the mill workers.⁸

Typical textile mill layouts featured the mill as the focal point, looming over the operatives' small and usually identical or nearly-identical houses, sitting side-by-side on streets laid out in a rigid grid pattern that reinforced the mill supervisors' and owners' notions of social order by imposing a spatial order on the landscape.

Between 1917 and 1925 Earle Draper and his Charlotte firm—which also had a branch office in Atlanta planned, designed, and laid out more than one hundred textile mill villages, most of them in the Piedmont region of the Carolinas and Georgia: Chicopee and Thomaston, Georgia; Forest City, Gastonia, Mount Holly, and Spindale, North Carolina; and Gaffney, Pacolet Mills, and Spartanburg, South Carolina. Architectural historian Margaret Crawford, an expert on Draper's work in Southern textile mill villages, observes that "Draper's planning style was most visible in two noteworthy textile towns, Pacolet Mill Village, South Carolina, built in 1919, and Chicopee, Georgia, his last textile project, built in 1925."9

The village Draper designed for Pacolet Mills was an excellent example of a general effort to redesign Southern textile mills and their villages in the period between the end of World War I and the advent of the agricultural depression of the mid-1920s. He emphasized the natural topography of the Piedmont, incorporating its rolling hills, rivers and creeks, and woodlands into his designs instead of building on the flat sites other textile mill planners often preferred. In Pacolet, the terraces and retaining walls, built of local stone, allowed the placement of houses on slopes and bluffs overlooking the mills and the Pacolet River, and along winding paved streets instead of in a grid pattern on dirt streets. A centrally-located park and

amphitheater on the bluff above the village was one means by which Draper's design encouraged the transformation of a regimented mill village into a true community, and a series of sidewalks, steps, and landings overlooking the river was another. Draper's influence even extended to the twenty-five different types or subtypes of houses built in the new Pacolet Mills village. "Although Draper did not design housing," Crawford notes, "he exercised considerable control over the choice of housing type; he favored the ground-hugging bungalow as an improvement over the frame mill house on piers." The Pacolet Mills Historic District is an outstanding example of Draper's innovative textile mill village plans. ¹⁰

The nominated property includes 129 contributing properties and 114 non-contributing properties along Stone, Milliken, Brewster, Goodlett, Cameron, Walker, Granite, Limestone, Moore, Green, and Cleveland Streets as well as Quarry Lane and Fleming and Montgomery Avenues. The properties within the district include representative examples of architectural styles constructed throughout the history of Pacolet Mills from ca. 1900 to ca. 1950.


